€ 5.42 billion Total Net Inflows in the first 5 months, € 3.33 billion into Managed Assets

Banca Mediolanum S.p.A. announces the business results for **May 2026**: **€1.17 billion**, of which:

- Total net inflows: **€785 million**, **€5.42 billion YTD**
- Net inflows into managed assets: **€631 million**, **€3.33 billion YTD**
- Loans granted: **€360 million**, **€1.67 billion YTD**
- General insurance premiums: **€22 million**, **€105 million YTD**

Massimo Doris, CEO of Banca Mediolanum, comments: “May results once again confirm the strength of our business model, with Total Net Inflows of €785 million, including €631 million into Managed Assets. Against a backdrop of significant geopolitical uncertainty and market conditions that continue to be characterised by volatility, our customers appreciate automatic investment services, which allow them to enter the markets gradually and in a disciplined manner over time, reducing the impact of market fluctuations and emotional decision-making. These solutions help customers build value consistently, enhancing the quality of the investment experience and reinforcing confidence in long-term investment choices.

We are also very pleased with the continued growth of our customer base, with more than 92,000 new customers in the first five months of the year, while the number of Family Bankers has increased to 7,089, up 4% since the beginning of the year. At the same time, we are seeing very positive trends in both Loans Granted and General Insurance Premiums, areas in which our advisory model continues to make a meaningful difference”.
