Communication of changes to the El.En.'s share capital

Firenze, June 25th, 2026 – El.En. s.p.a., leader on the laser market listed on the Euronext STAR Milan ("STAR") of the Italian Stock Exchange, hereby gives notice of the changed amount of its share capital pursuant to art. 85-bis Consob Issuers' Regulation.

Following the exercise by certain beneficiaries of the 2026-2031 Stock Option Plan approved by the Board of Directors on March 15th, 2023, of the options granted to them for the subscription of newly issued ordinary shares, the company issued, in the period included between May 28th, 2026, and June 22nd, 2026, n. 43.000 ordinary shares for an amount of nominal euro 1.397,50.

Therefore, as of June 22nd, 2026, the El.En.'s share capital signed and paid-in amounts to euro 2.613.895,44 equal to n. 80.427.552 ordinary shares.

The certification concerning the new amount of the share capital has been filed for registration with the Register of Companies of Florence as of today's date.
