## Fineco strengthens its organisational structure to accelerate growth

**Romualdo Guidi, Chief Business Officer**, with responsibility for the Banking, Brokerage and Investing platforms, Markets and the Retail and Private Banking Products areas.

**Fabrizio Lingesso, Chief Marketing & Communication Officer**, with responsibility for centralizing marketing, brand and communication activities in support of all the Bank's product lines, both in Italy and internationally.

**Alessandro Annoni, PFA Network Controls and Commissioning Department**, with a strategic and advisory role supporting the Co-General Manager in overseeing the development and management of PFA network.

**Fabrizio Brancaccio, Chief Lending Officer Department**, with responsibility for all the Bank's credit-related activities.

Fineco also announces the mutual termination of the professional relationship with Deputy General Manager **Mauro Albanese**, thanking him for his contribution to the development of the Personal Financial Advisors network since 2008.

**Lorenzo Di Pietrantonio**, currently Chief Investment Officer of Fineco Asset Management, has been appointed CEO of the subsidiary.
