DHH completes the acquisition of Tessellis Group's Perimeter B.1

Milan, 29 July 2026. DHH S.p.A. (DHH.MI) (ISIN shares IT0005203622 | ISIN warrants IT0005645541) (“**DHH**” or “**Company**”), further to its press releases dated May 20, 2026, May 22, 2026, July 1, 2026 and July 14, 2026, to which reference is made for further details, announces that it has today completed the acquisition of the B2B business unit of GO Internet S.p.A., including the equity interest held in X-Stream S.r.l. and the equity interest held by Tiscali Italia S.p.A. in Aetherna S.r.l., as previously disclosed to the market.

Concurrently, DHH has initiated the reorganization of the acquired perimeter through the transfer, completed today, of GO Internet S.p.A.’s business line to X-Stream S.r.l.

The total value of the transaction amounts to Euro 4.200.000 and was paid in full at closing using DHH’s available cash resources.

The financial results of the acquired companies will be fully consolidated into DHH’s financial statements starting from August 2026.

The completion of the transaction marks a further step in the implementation of the Company’s external growth strategy. The acquired perimeter contributes approximately Euro 12,7 million in revenues, more than 80% of which are recurring, together with positive EBITDA and a customer base of more than 3.000 business clients. The transaction further strengthens DHH’s position in the Italian telecommunications and ICT infrastructure market while expanding the recurring revenue base on which to develop future industrial synergies with the Group’s other companies.
