Florence, August 12, 2026 - With reference to the program for purchasing treasury shares authorized by the Shareholders' Meeting held on April 23, 2026, whose launch has been also resolved by the Board of Directors held on May 27, 2026, as communicated to the market on the same date also according to article 144-bis of the Consob Regulation no. 11971/1999, Salvatore Ferragamo S.p.A. (Euronext Milan: SFER), parent company of the Salvatore Ferragamo Group, announces that it has purchased on Euronext Milan organized and managed by Borsa Italiana S.p.A., during the period 08/04/2026 – 08/11/2026 no. 109,793 Salvatore Ferragamo S.p.A. ordinary shares (ISIN code: IT0004712375), equal to 0.07% of the share capital, at an average unit price of Euro 9.63 per share, for a total countervalue equal to Euro 1,057,512.90.
