Florence, September 7, 2026 - With reference to the program for purchasing treasury shares authorized by the Shareholders' Meeting held on April 23, 2026, whose launch has been also resolved by the Board of Directors held on May 27, 2026, as communicated to the market on the same date also according to article 144-*bis* of the Consob Regulation no. 11971/1999, Salvatore Ferragamo S.p.A. (Euronext Milan: SFER), parent company of the Salvatore Ferragamo Group, announces that it has purchased on Euronext Milan organized and managed by Borsa Italiana S.p.A. and on MTF DXE Order Books organized and managed by CBOE Europe (NL), during the period 08/28/2026 – 09/06/2026 no. 60,900 Salvatore Ferragamo S.p.A. ordinary shares (ISIN code: IT0004712375), equal to 0.04% of the share capital, at an average unit price of Euro 9.00 per share, for a total countervalue equal to Euro 547,835.88.

On the basis of information provided by the intermediary in charge of executing the purchases, below there is a summary of daily purchase transactions made on Mercato Telematico Azionario, in aggregate form:
